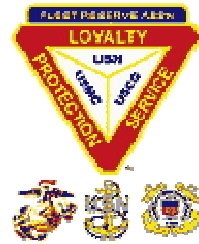

### **UNFINISHED AND DEFERRED BUSINESS:**

### **NEW BUSINESS:**

1. BOD minutes read and discussed
2. **Motion** Moore, second Doty to pay Building and Maintenance P10,000 for box bar completion. Reusable materials will be re-used in the roof repair project. Native materials will be used for the box bar roof to keep it in synch with the horse shoe bar. Approved unanimously
3. Michenko: 22 sponsors have signed up to be plank owners of the new box bar with native roof and bar stools. Sponsorship is P1000 per person. State-side members feel free to jump in on the new box bar (real name TBD) sponsorship. All plank owner's names will be proudly displayed on plank owner tags. Sponsorship will be limited to 50.
